Terms and Conditions

By signing this application, I authorize Red River Communications to check my credit history to determine if a deposit is required. I agree to maintain my local telephone service. All equipment used to provide Digital TV service remains the property of RRC. I may need to purchase replacement equipment if damaged through other than normal usage. I give permission to RRC to monitor viewing patterns and practices for internal purposes only and not for sale to or shared with a third party. By allowing pay-per-view, I agree to pay all pay-per-view charges. Packages, lineups, pricing and terms are subject to change without notice. RRC will provide advance notice of these changes when possible. A deposit may be required based on credit history. A \$14.50 fee is assessed if downgrading to a lower channel package. There is a \$24.50 fee for non-pay reconnection. Taxes, EAS and mandated fees plus a Local Broadcast Retransmission Fee of \$7.83 per month apply. Federal law requires TV providers to get consent to retransmit to local stations and TV providers are charged a retransmission fee. These fees are returned to the local broadcast stations.

Cancellation Policy

I agree that I will retain Digital TV service from Red River Communications for the agreement length selected above. Termination before the agreement length has been completed will result in an early termination fee equal to the prorated amount of installation value (up to \$240.00), repayment of promotional items, and/or forfeiture of other promotional offers. A \$20.00 per month penalty will apply for each month remaining on the agreement. Any temporary suspension of service will extend the agreement length by the same period of time as the temporary suspension. A \$24.50 fee applies to reconnection of accounts disconnected for delinquency. Termination fees apply to voluntary or involuntary termination, but do not apply if the agreement is expired or if no agreement length was selected. Failure to return equipment (when applicable) will result in a \$50.00 per device fee.
